

Hello Spicy Southwest,

From the very beginning of my journey in the brotherhood, literally, nothing has gone as expected. Shortly after I was initiated, I developed numerous serious health problems that lead to the diagnosis of two chronic conditions and two surgeries. Although unexpected and difficult, this journey has brought me an astonishing amount of growth and wisdom gained through my experiences. As per my fortune in predictability, it was only fitting that the trend continued with my election to district council. As some of you may remember, I was not running for Vice President for Membership... nor did I have any experience as a VPM. However, serving in this office has been one of the best and most rewarding experiences I have had the privilege of doing.

This year has been nothing short of a challenge. The continuous uncertainty and constantly changing guidelines as cases would rise and fall, left no two universities on the same page in terms of policies. After National Convention, my counterpart, Madison, and I were hopeful most things would be back to "normal", but in preparing for Chapter Leadership Conference, we had to make the difficult decision to keep these events online to maintain our brothers' safety during the rise of cases. While chapters were preparing for their fall semester, Nationals released a new PIVOT guideline allowing chapters to operate under the procedures set by schools. For most chapters, this was encouraging because they were finally able to resume in-person recruitment events, lessons, and rituals. For others, it was terrifying because none of their brothers had seen how a chapter operated in a non-virtual setting. Coming into this office, I was brainstorming plans but quickly realized chapters simply needed guidance and resources on how to do the things in person.

When Madison and I started preparing for Area Workshops, we were again hopeful that this would be in-person and we would be able to pick up where we had left off two years ago. But again decided to continue to host these virtually. When discussing workshops for these events, we decided that the best thing for the district was to provide brothers with workshops to re-connect to the brotherhood, discover new ways to operate, and provide resources for mental health awareness. Presenters were contacted, and the schedule was finalized at Winter Council. These events were an incredible joy to plan, and it was amazing getting to see chapters from across the country who may not have otherwise been able to attend.

At the very beginning of my term, I created a GroupMe with all of the Chapter VPMs to quickly share resources and important information. The office of VPM entails quite a bit of paperwork done through the *lovely* OMRS - recruitment calendars, education process calendars, activity review forms, membership candidate registration forms, and initiation forms. Because of the wide variety of university policies across the district, I did everything I could to provide all the resources available to all VPMs and stay up-to-date on as many universities' policies as possible to be as much of a help to as many VPMs as possible.

This opportunity to serve the district has offered me opportunities to grow like no other despite every unimaginable curveball. I was gently *shoved* out of my comfort zone, and I could not have done it without

the support of my fellow district officers, governors, and my chapter. The lessons I learned, I hope to share with brothers, my students, and myself in hard times. There were numerous times this past year when I doubted myself and my ability to serve in this capacity, but I was surrounded by those who love me and constantly remind me of my worth and value as both a brother and a human being.

- ASK FOR HELP it will be something you will do constantly and someone is more than happy to answer you
- Stay up to date with any new Guidance on Rituals and work with the National Leaders if they are to continue to be held virtually

The 2022 Spirit and Recognition Committee was charged with the following:

The Spirit & Recognition Committee began its meeting with introductions of members of the committee, followed by consideration of the past year's committee report and charges for the 2022 committee. After we ensured that all chapters who applied were eligible, we established a criteria for each of the 4 Pillars awards and the Outstanding Service to Music Education award. Special consideration was given to those chapters that displayed an emphasis on inclusivity throughout their projects and operations.

Each application that the committee received was extremely detailed and gave each member more than enough information to deliberate on our decisions. Each chapter not only expanded upon their philosophy concerning the 4 Pillars, but also outlined specific actions they were taking as a chapter to fulfill the purposes of each pillar. • Prepare a slate of one candidate for each position that committee feels would benefit the district most. If the committee feels that no one candidate is most qualified then the committee can announce "no slate" for any or all offices

• Recommend and changes to the nominations/election process to the jurisdiction committee as needed.

We began by reviewing the 2021 Nominations Committee Report and Charges.
